



Waiver, Release, and Hold Harmless Agreement

In consideration for entering and/or participate in any activities at Kidz Place Family Fun Center Inc., I, the undersigned, and on the behalf of any child/children in my care, acknowledges, understands, and agrees to the following:

I am the parent, legal guardian or representative of the child/children listed below or I have obtained the permission from the parent/legal guardian of said child/children to execute this agreement on their behalf.

I, for myself, and the child/children in my care, agree to comply with all the stated rules including but not limited to the posted safety signs, policies, and verbal instructions as condition for participation at Kidz Place Family Fun Center Inc.

I, for myself, and the child/children in my care acknowledge and agree to comply with the following terms:

Use of Kidz Place Family Fun Center equipment is at my own risk. Kidz Place FFC Inc. is not responsible for any accidents, injuries, personal items or property – I acknowledge and understand the risks associated with the activities and use of equipment at Kidz Place Family Fun Center Inc including but not limited to cuts, bruises, and scrapes. I willingly agree to assume the risks associated with participation and acknowledge that there are also risks that may arise due to other participants that I willingly assume.

All shoes must be removed and placed in the cubby provided prior to entering Jungle Gym and inflatable. Socks are required. Face masks are optional unless mandated by the local, state and/or federal government.

Children must be accompanied and supervised by an adult (age 18+) at all times.

No toys, sharp objects, food, and/or beverages allowed in the Inflatable and Jungle Gym.

No sliding head first down the slides and climbing up the slides of the Jungle Gym

No climbing on structures including but not limited to: the top of Play Card operated rides, arcade games, the nets on the Jungle Gym, tables, chairs, walls, and furniture.

No roughhousing, pushing, or running in the center.

No food or beverages allowed in the Jungle Gym and Inflatable and no outside food allowed in the center.

No playing in age-restricted areas – I acknowledge and accept that there are age restrictions for certain activities and will ensure that the child/children in my care will only play in areas that meet their age, weight, and height requirements. I willingly bear full responsibility for any injuries incur to any child/children in my care while playing at the center.

I attest that each child in my care is in good physical health and is able to fully participate in the appropriate activities within Kidz Place Family Fun Center. I further attest that I am willing to assume the risk of any medical or physical condition of the child during my visit to Kidz Place Family Fun Center.

I further consent to Kidz Place staff taking temperature of me and the child/children in my care, and I acknowledge that the child/children and I may be denied access to or be asked to vacate Kidz Place Family Fun Center if either of us evidence any symptoms of sickness or illness, including, without limitation, symptoms of exposure to bacteria, fungus, viruses, unknown contagious diseases, or COVID-19.

I am aware of the risk of exposure to COVID-19 or any other communicable diseases in public spaces where people are present. I, for myself and the child/children under my supervision, willingly assume any risks associated with our presence and participation at Kidz Place Family Fun Center.

By signing this I, for myself, the child/children in my care, our heirs, assigns, administrators, personal representatives, and next of kin release and hold harmless the owner of this facility, Kidz Place FFC Inc., their owners, affiliates, officers, members, agents, employees, other participants, and sponsoring agencies from and against any and all claims, injuries, liabilities, or damages arising from or related to our participation at Kidz Place Family Fun Center.

I, for myself, and on behalf of the child/children in my care understand that the completion of this waiver on the initial visit will authorize Kidz Place FFC Inc. to enter this waiver into its database and use it as a continuous, multi-use waiver for ongoing participation at Kidz Place Family Fun Center Inc. until I revoke it in writing.
